Sir/Madam,

In terms of section 14(1) of the NCTE Act, 1993, the above, Medapaty Surreddy and Achayamma Educational Society, Plot No.4-120, Ramalayam Street, Eletipadu Village and City, Penugonda Post, Iragavaram Mandal Taluk, West Godavari District – 534 320, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting D.El.Ed - AI Course of two year duration with an annual intake of 50 students at VASM Reddy College of D.Ed, Khasara No.4-120/4.2,4.3,4.4,4.5, Plot No. 4-120, Ramalayam Street, Eletipadu Village, Penugonda Post, Iragavaram Mandal Taluk, Eletipadu City, West Godavari District – 534 320, Andhra Pradesh.

On the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography, the SRC in its 225th Meeting held on 26th-27th June 2012 is satisfied that the above institution has adequate financial resources, accommodation, library, laboratory as prescribed in the norms and standards and that it fulfils all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course and decided to issue Letter of Intent prior to grant of recognition under clause 7(9) of NCTE Regulation for grant of recognition to D.El.Ed - AI course of two year duration with an annual intake of 50 students only (one unit) for the academic year 2012-2013 subject to appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of academic session.

Before grant of formal recognition under Regulation 7(11) you are requested to submit the following:

The institution shall make appointment of faculty / staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. After appointment of faculty/ staff, Affidavits as under should be submitted

- a. **Annexure - I** - An Affidavit on Rs.100/- stamp paper to the effect that the institution has appointed staff as per NCTE/State/University norms.
- b. **Annexure - II** - An affidavit on Rs.10/- non judicial stamp paper by the individual faculty member appointed by the institution.
- c. **Annexure - III** - Details should be filled by every faculty member appointed

Format of Annexures - I, II & III are enclosed along with this letter.


The institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, class rooms and other facilities/amenities), instructional facilities (laboratory, library etc.,) and the particulars of the appointed teaching and non-teaching staff etc., with photographs. The details of the website shall be submitted.

1. Before issuance of formal recognition order, the institution should convert the Endowment Fund of Rs.5 lakhs and Reserve Fund of Rs.3 lakhs in to joint account with SRC-NCTE. Copies of the FDR's converted into Joint account should be submitted.
2. You are advised to comply the above requirement before formal recognition is considered under Regulation 7(11).

Admissions should not be made until formal recognition order under Para 7(11) of the NCTE (Recognition Norms & Procedure) Regulations, 2009 is issued by the SRC, NCTE and affiliation is obtained from the University/examining body concerned.

Reply to the LOI should be submitted within 2 months.
